# REGULAR BOARD MEETING October 28, 2015

The regular meeting was called to order by President Sponseller at 8:30 a.m. in the basement of the Hotchkiss Library on October 28, 2015.

Whittlesey moved to accept the corrected minutes. Colwell seconded the motion and it carried.

### Treasurer's Report:

We have a total of \$14,189.18 in all accounts on 10/28/15. \$8032.52 in checking and \$6156.66 in special projects. Deposits for Sept. were \$7857.00. Expenses were \$4075.62.

# Communication Secretary Report:

- NFV.net is done thanks to Colwell and Nikole James. Colwell has been trained on how to do the updates.
- Tuesday membership emails have a 45% opening which is very good.

Presentations: Dawnette Simpson from the NF Ambulance Association shared ways we can help promote membership in the Association. (Women in Business, membership applications in New Neighbor bags). There are now over 1168 members. Sixty are new. The Association is providing free CPR classes on the 3<sup>rd</sup> Saturdays. There is also a health provider course.

#### Old Business:

- Painting the back of the North welcome sign was discussed. Royal Tone Painting gave a
  quote of \$220 to do everything left on the sign. Ihnot moved that we hire them to do the job.
  Yantzer seconded the motion and it carried. It was also decided to pay Bill Long \$61.38 for
  the sign expenses he has incurred.
- The Hotchkiss brochure is almost done. Sponseller is finishing up some last descriptions.
- Duclo reported on the Art and Craft Fair. The ballroom is full and the Addams room only has a couple of spaces left. The Emblem Club will be serving the lunch.
- Annual Meeting Whittlesey made and Ihnot seconded the motion to set a budget of \$300 for the food for the meeting. The motion carried. Taco Hut will be preparing the food.
- Three board positions will be open. Sponseller, Long and Ihnot agreed to continue in those
  positions. Duclo asked to be replaced. There is one year left in her term. Several people
  were suggested as replacements.
- Nominations were made for Business of the Year, Citizen of the Year and Non-Profit of the Year. No one had any changes that need to be made in the By-Laws.

#### **New Business:**

- There will be a member Thank-you ad (half page) in the Nov. 11 High Country Shopper and (quarter page) Delta County Independent. There will be a similar ad in the Merchant Herald at the end of November.
- Membership Mailing was discussed. Ihnot moved that we have separate mailing for present members and prospective members. New members will be targeted. Whittlesey seconded the motion and it carried. It was decided not to combine the mailing with Paonia and Crawford.
- Outreach Committee The Business After Hours at the Rose was a great success. There are 14 Welcome bags made up, but we are looking for items to put in the next group. Gonzales would like to provide something.
- Downtown Improvement report by Mary Hockenbery. Youth Art Wall: There was a bill for \$421.93. Shannon Castle's group worked with 2'x8' panels. There was also discussion on the flowers. Artists are encouraged to donate art flowers to be sold. The Town has been asked for \$1000 for the project.
- Announcements: Cambria said the High School will be doing the play "Chemical Bonding: Better Living Through Chemistry" on Dec. 3 & 4 at 7:30 p.m. She also reported on improvements at the swimming pool. They will be selling membership card at the Arts & Craft Fair for gifts.

The meeting was adjourned.
